ORDER

A status conference was held on February 18, 2010, at which multiple issues were addressed. Based on the discussions and rulings at that conference the following is ordered.

IT IS HEREBY ORDERED that the parties shall submit a proposed case management order regarding the taking of depositions no later than **February 26, 2010**.

IT IS FURTHER ORDERED that Defendants' European Union custodian documents are due to be produced, per my Order of December 1, 2009, no later than **February 26, 2010**. If Plaintiffs challenge the scope of Defendants' production of these documents Plaintiffs shall file a motion no later than **March 22, 2010** regarding this production.

IT IS FURTHER ORDERED that the parties shall submit a joint proposed case management order regarding a discovery schedule for Phase One cases no later than **March 22, 2010**.

IT IS FURTHER ORDERED that Defendants' review and revision of privilege log documents shall be completed and all documents removed from the privilege log produced to Plaintiffs no later than **March 22, 2010**.

IT IS FURTHER ORDERED that Defendants shall produce all draft marketing materials addressed at the December 1, 2009 status conference no later than **March 22, 2010**.

IT IS FURTHER ORDERED that Defendants shall provide Plaintiff with answers to Plaintiffs' interrogatories no later than **March 12, 2010**.


IT IS FURTHER ORDERED that Defendants shall file a list of Plaintiffs whose fact sheets are 60 days overdue and a list of Plaintiffs whose medical authorizations are missing or are incomplete by **February 22, 2010**. Plaintiffs shall provide Defendants with this missing information no later than **March 22, 2010**.

IT IS FURTHER ORDERED that the parties shall each reduce their list of Phase One cases from 16 to 13 case no later than **March 22, 2010**.

IT IS FURTHER ORDERED that Plaintiffs' shall submit any case orders in other MDLs in support of their motion to file cases directly in this MDL no later than **March 15, 2010**. Defendants may file a response no later than **March 22, 2010**.

IT IS FURTHER ORDERED that any motion to compel or for a protective order arising from the requirements of this order shall be filed no later than **March 30, 2010**.

IT IS FURTHER ORDERED that a scheduling conference is set on **April 6, 2010 at 9:30 a.m.** in Courtroom 10 South. The parties shall submit a proposed agenda for the conference no later than **April 2, 2010**.
