## STIPULATED ORDER REGARDING DEFENDANTS' MOTION TO COMPEL DISCOVERY IN CERTAIN PHASE I CASES

AND NOW, this 20th day of December 2010, it is hereby ORDERED that Defendants' Motion to Compel Discovery in Certain Phase I Cases is GRANTED in accordance with the following terms:

- A. Deadlines for Plaintiffs' responses to interrogatories and document requests:
- (1) On or before January 17, 2011, Plaintiffs will provide responses to Interrogatories 1-3, 9-12 and Request for Production of Documents 1-7, 11-12.
- (2) On or before February 15, 2011, Plaintiffs will provide responses to Interrogatories 4-8 and Request for Production of Documents 8-10, 13-14.
- B. The Parties agree to the following modification of language in Defendants' discovery requests as follows:
- (1) Where the interrogatory asks for "all facts," the request shall be deemed modified to ask for "the facts and bases."
- (2) Interrogatories 2, 3 and 9 are deemed to be specifically made to the answering Plaintiff.
- (3) Where the term "bates numbers" is used in the Request for Production of Documents, this term is clarified to refer to the bates numbers used by Defendants

or the serial numbers used by Defendants' record collecting service. If no such bates number has been applied to the responsive document, then Plaintiffs shall otherwise adequately describe the document.
