If necessary, the parties shall file an agreed upon limited protective order concerning the disclosure of the identities of the Doe plaintiffs no later than **Monday, February 15, 2016**.

IT IS FURTHER ORDERED that the deadline for Plaintiffs to file a consolidated class action complaint is **Tuesday**, **March 22**, **2016**. Defendants shall have thirty (30) days to file responsive pleadings, up to and including **Thursday**, **April 21**, **2016**. Any reply shall be due no later than **Friday**, **May 6**, **2016**.

IT IS FURTHER ORDERED that in light of the written motion of Barnes & Thornburg, LLP and the oral motion of Leslie Weiss to withdraw as counsel for Defendants Avid Life Media Inc. and Avid Dating Life Inc., Plaintiff's Motion for Leave to File Motion to Disqualify Under Seal, Ultimately Seeking A Ruling Disqualifying Defense Counsel Defendants Leslie Weiss and Barnes & Thornburg LLP [48] is **DENIED** as moot.

IT IS FURTHER ORDERED that Plaintiff's Motion for Leave to File Under Seal, Ultimately Seeking A Ruling that the Crime-Fraud Exception to the Attorney Client Privilege Applies to Email Communication between Defendant and its General Counsel and Defendant and Barnes & Thornburg LLP for the Time Period of January 11, 2012 to September 1, 2015 [49] is **DENIED** without prejudice as premature.

IT IS FINALLY ORDERED that status conferences with counsel are scheduled for Friday, March 4, 2016 at 10:00 a.m. and Friday, April 8, 2016 at 10:00 a.m. in Courtroom 12N. Thereafter, the Court will hold regular status conferences with counsel on the first Friday of
