

## JUROR INFORMATION

Jurors serving in the U.S. District Court for the Eastern District of Missouri in Cape Girardeau are selected from the residents of eighteen Missouri counties which are within the geographical boundaries of the Southeastern Division of the Court. The Rush Hudson Limbaugh, Sr. United States Courthouse is located at 555 Independence Street in Cape Girardeau (At the Intersection of Frederick and Independence Streets). It is accessible from Highway 61 and Interstate 55. For a map and driving directions to the Courthouse, visit the Court's website [www.moed.uscourts.gov](http://www.moed.uscourts.gov), go to the heading Jurors and click on Cape Girardeau.

### ATTENDANCE FEE & MILEAGE

\$50 per each day in attendance plus 56 cents per mile travel allowance mileage is calculated automatically). Federal Government employees are not paid unless appearing on their day off. They must present a signed statement from their supervisor verifying their leave status.

### PARKING

Jurors may park in the public parking lot accessible off Frederick Street on the south side of the Courthouse.

### SUBSISTENCE ALLOWANCE

If a juror's residence is at least 100 miles in distance one way from Court, or when authorized by the Clerk of Court, a subsistence allowance for an overnight stay may be paid to a juror at the appropriate daily rate for travel or attendance. A copy of your hotel/motel receipt is required in order to reimburse subsistence.

### PAYMENT

Checks in payment of service fees, travel, and subsistence allowance are mailed to jurors approximately twice a month. Mileage and subsistence fees are not taxable, but the \$50 daily attendance fee is taxable and should be reported on your income tax returns.

### CHANGE OF ADDRESS OR OTHER INFORMATION

If you have a change of address, phone number or change of employment please be sure to submit these to the Court as soon as possible. A current address is needed to mail your checks since the Post Office does not forward checks.

A current phone number is also important when cases settle or to contact you by the court's automated phone system.

## TERM OF SERVICE

The term of jury service is set as a three month on call period. However, **actual jury service is very limited during this period.**

The Court attempts to minimize disruptions to jurors' schedules.

Many trials in this Court average three days long. If you report for jury duty and are not selected, you need not return until you receive another notice, unless otherwise instructed by the Courtroom Deputy.

During your term of service, notices to report are sent usually ten days in advance. The written notice will contain instructions for reporting and either checking online or calling the court's automated phone to confirm whether or not you need to appear on a reporting date. You may be informed that you have been rescheduled to report on a certain date; if so, you should follow the directions given in the phone or online message.

**When you report, you need to allow for a full day for jury service. Jury service can commence early in our court, and it is critical that you report on time. You should allow yourself enough time for travel and parking.**

## CERTIFICATE OF ATTENDANCE

If your employer requires written verification of your attendance for jury service, you may obtain a certificate of attendance.

## SCHEDULE CONFLICTS

If you have a planned vacation or scheduled doctor's appointments during the term, please note the dates at the bottom of your Juror Information Form or submit a partial excuse request through eJuror, and the Court will be able to work around these dates when scheduling your appearance.

## REQUESTS FOR EXTENSION OR TO BE EXCUSED

**All requests for an extension of or excuse from jury duty, for a valid reason, must be in writing and sent either by mail or online to the Court for consideration, along with your completed Juror Information Form.**

**If you are seeking to be excused for medical reasons, you will need to enclose a statement signed by your M.D., D.O., or Nurse Practitioner regarding your inability to serve.**

The request for extension or an exemption should be sent within ten days of receiving your summons.

If you submit a request, **it is your responsibility to verify the court's determination on your request by calling the court's automated phone system at 1-866-237-3367 or checking online through eJuror at [www.moed.uscourts.gov](http://www.moed.uscourts.gov).**

Information received by the jury clerks is updated in our telephone system and online daily.

You will not be paid for appearing if excused on the day you report.

**Failure to obey this jury summons may be punishable by fine, imprisonment and/or community service, or any combination thereof.**

During your term of service, if there is an emergency, etc., please notify the jury clerk by phone as soon as possible at 573-331-8800.

## **eJUROR ONLINE PROGRAM AT WWW.MOED.USCOURTS.GOV**

You can complete your Juror Information Form, check your reporting status, or request an excuse, postponement or partial excuse (excuse from certain date(s) during the term). You will need your nine-digit Juror Participant Number located above your name and address on your summons to access the program. If requesting an excuse or postponement online, complete the form first, then log out of eJuror and log back in. You will then see the menu option to submit a request.

When using eJuror to check your reporting status (Current Status), **you MUST WAIT UNTIL AFTER 4:30P.M.** on the last business day before your reporting date to check for updates or changes. The trial schedule can change up until 4:30P.M., so your reporting status will only be valid after that time. If eJuror is not accessible, you must call the Automated Phone (AJIS) for your reporting information or changes.

After your service, you can print a duplicate Certificate of Attendance if needed for your employer or records.

## AMENITIES FOR JURORS

Complimentary coffee and snacks.  
Wireless internet service in the jury assembly room.  
Refrigerator and microwave in jury assembly room for jurors who bring their lunch.

## ATTIRE AND ETIQUETTE

**TANK TOPS, SHORTS, AND SWEAT PANTS ARE NOT PERMITTED IN THE COURTROOM.** You will be sent home without being paid or directed to return home and change at your expense if inappropriate attire is worn.

Food and drink are not permitted in the courtrooms.  
Jurors may not read personal materials while court is in session.  
Smoking is not permitted in the Courthouse.  
Cell phones must be turned off in the Courtroom.

## ALLOWED AND PROHIBITED ITEMS

Jurors may bring: Cell phones, laptops, food and drink, books and magazines.  
Examples of items NOT allowed in the Courthouse: Scissors, knitting needles, fingernail clippers, pocket knives, mace.  
The Judges of this Court hope you will find your jury duty interesting and instructive.

**How To Use The Automated Jury Information Service (AJIS)**  
**AJIS TOLL FREE NUMBER: 1-866-237-3367**

The court uses an automated telephone system to inform jurors of their status and to provide reporting instructions. **You will need to have your summons with you when you call.**

For reporting instructions:

- (1) **Dial the number listed above.**
- (2) **Press 1**
- (3) **Enter your nine-digit participant number located just above your name/address on your summons.**
- (4) **Press 1 to verify the first three letters of your last name.**
- (5) **Listen to the message in its entirety.**

Please do not call the automated telephone system until you have returned your information form to this office. Our automated system also provides a computer-generated courtesy reminder call, so **please be certain to provide your telephone number on the Juror Information form** you return to the court so we may contact you, as needed.

You will be instructed to call in after 4:30 P.M. on the last business day before the date you are scheduled to appear. If you are scheduled to appear on a Monday, you may call after 4:30P.M. on Friday.

The call is free and can be dialed from any location. You will be directed to report either on the date summoned, or rescheduled to appear on another date, and will be instructed to call the automated message again to confirm after 4:30P.M. the last business day before you are scheduled to report, or notified that you do not need to appear and will be notified by mail when next scheduled to appear.

To receive information regarding the status of your request for postponement or excuse, call the AJIS phone number (866) 237-3367. To hear your updated status, please wait at least 10 days after submitting your juror form and request.

Cases can be settled or dismissed shortly before trial, so it is imperative that you call the automated system or check online for your reporting status, because **YOU WILL NOT BE PAID IF YOU REPORT FOR JURY DUTY AND THE RECORDED MESSAGE OR eJUROR NOTIFIED YOU NOT TO APPEAR.**

**DO NOT CALL THE AUTOMATED SYSTEM AFTER YOU HAVE BEEN SELECTED TO SERVE AS AN ACTUAL OR PROSPECTIVE JUROR IN A CASE IN PROGRESS. THE JUDGE PRESIDING AT THE TRIAL OR THE COURTROOM CLERK WILL GIVE YOU INSTRUCTIONS AS TO WHEN YOU ARE TO RETURN TO COURT UNTIL THAT TRIAL IS COMPLETED.**
